2021 Membership Liability Waiver and Hold Harmless Agreement

- 1. In consideration for receiving permission to participate and use the *Firearm and Archery Ranges:* I hereby knowingly and release, waive, discharge, and pledge, not to sue the Windsor Fish and Game Association, its Officers, Servants, Agents, Employees, or Representatives (hereafter referred to as the "Releases") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of (or relating to) any loss, damage, or injury (mental, emotional, physical, or monetarily), up to and including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Releases or otherwise, while participating in (or exercising the use of) the GUN / ARCHERY RANGES or other actions upon the premises.
- 2. I am fully aware of the risks and hazards connected or associated with being on the premises and participating in the use of the GUN / ARCHERY RANGES. I am fully aware that there may be other, unknown to me, risks and hazards connected with being on the premises and participating in the use of, or observation of, the GUN / ARCHERY RANGES. I hereby avow and elect to voluntarily participate in the use or observation of the GUN / ARCHERY RANGES, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I knowingly and voluntarily assume full responsibility for any risks of loss, property damage, personal injury (including death), that may be sustained by me as a result of my being a participant in, or observer, of the GUN / ARCHERY RANGES, whether caused by the negligence of the Releases or otherwise.

 3. I further hereby agree to indemnify, save, and hold harmless, each of the Releases from any loss, liability, damage, or costs that may be incurred, due to my presence upon the property and or participation in and of the GUN /ARCHERY
- costs that may be incurred, due to my presence upon the property and or participation in and of the GUN /ARCHERY RANGES, whether caused by the negligence of any or all of the Releases or otherwise.
- 4. It is my express intent that this Agreement shall act to bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives. If I am deceased, this Agreement shall be deemed a Waiver, Release, Discharge and Covenant Not to Sue the above named Releases.
- 5. I hereby certify that the above and all accompanying statements are true; that I am a Citizen or Legal Resident of the United States of America; that I am not a member of, or associated with, any organization which advocates, as any part of its agenda, the violent overthrow of the United States Government and/or any of its political subdivisions; that I have never been convicted of a felony, and/or crime of violence; that I, and any of my guests and/or family members, meet all legal requirements for firearms ownership/possession at national, state and local levels. If admitted to the club, I will faithfully endeavor to fulfill my obligation of good sportsmanship, stewardship, obey the range safety rules, and comply with the range use policies, membership requirements and any subsequent written and/or verbal rules/instructions of the Windsor Fish and Game Association. I understand that any violations of the preceding may result in immediate termination of membership with no reimbursement of funds.
